





# Priorités de recherche H2020 -1

## Organic research & innovation programme to overcome challenges of new regulation

- Alternatives to critical inputs used in organic agriculture  
Copper, mineral oils, conventional manure, sulphites
- Availability of organic seeds – towards 100% organic seed
- Eco-efficient production of animal feed at local level
- Organic food processing concepts and technologies
- Supporting the development of a diverse organic sector  
Developing organic farming policy, improving certification,  
improving transparency of organic markets

## Research & innovation for the further development of organic and agroecological food systems

- Innovative ICT tools for organic cropping systems
- Precision farming, use of sensors
- Public health effects of organic food system in Europe
- Agro-ecological and organic farming pathway to improve food security and rural development in Sub-Saharan Africa and South Asia


